Terms and Conditions

Renter Responsibility

The renter is responsible for all activities of the passengers on board the bus. This includes making sure that all passengers who consume alcohol while on the bus are 21 years of age or older.

Bus Deposit/ Cancellation Policy

A \$200.00 deposit is required to secure your bus reservation and serves as a damage deposit.

If you choose to cancel your reservation prior to 14 days of your rental date, it will result in forfeiture of your deposit. If you choose to cancel your reservation with 2- 14 days of your rental date, it will result in one half of the total rental amount being charged. If you choose to cancel your reservation within 48 hours of your rental date, it will result in the total rental amount being charged to the card on file. If you choose to cancel you must write canceled across this rental agreement and send back via fax, mail or email to the above address.

If there is any damage to the bus or excessive cleanup is required, a damage assessment will be made and all or a portion of your deposit will be forfeited. **Additionally, a clean-up fee of \$200.00 will be charged if any passenger vomits on the bus.** Any damage assessment will be determined once the bus has returned to the shop and has been thoroughly cleaned.

Payment

Full payment in cash must be received prior to boarding the bus.

Alcohol Policy

Alcoholic and non-alcoholic beverages are permitted. Kegs are allowed. No glass bottles will be allowed. Cans and plastic containers are welcome.

Anyone consuming alcohol while on board the bus must be 21 years of age or older. Random search by driver may occur for all underage parties i.e. proms, dances, etc.

Smoking/ Food Policy

No smoking or food will be allowed on the bus.

Rules of Conduct

No fighting, weapons or drugs will be tolerated. Violation will result in the immediate termination of the bus run. No refunds. No exceptions.

Have fun, but please be conscious of your own safety and the safety of others.
